

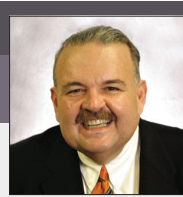
**JOHN H. (JACK) HICKEY**

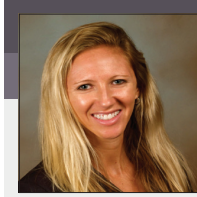
